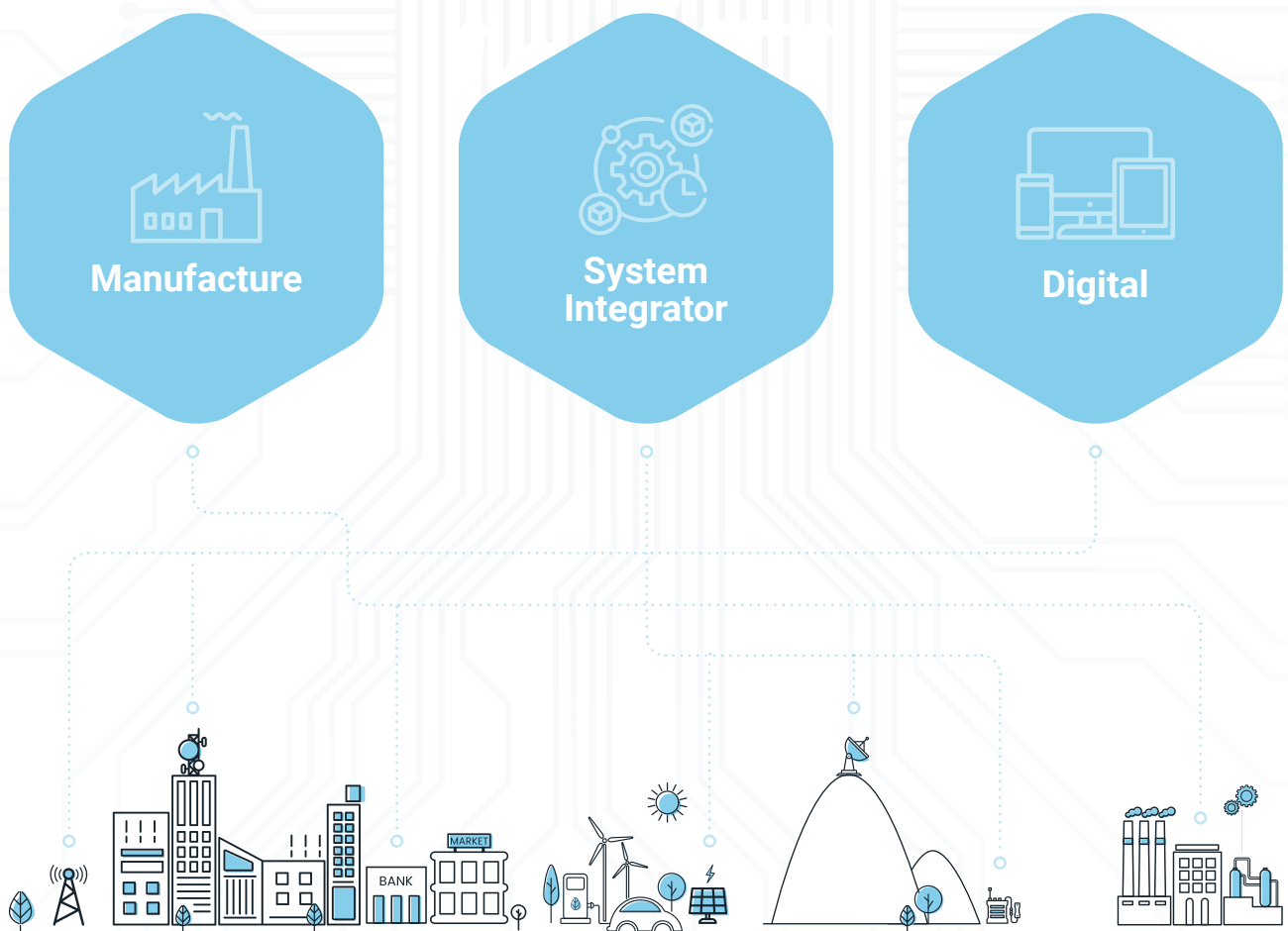
Business Line
